The staff at these programs evaluate children for developmental delays and other developmental or behavioral concerns. ## AREA PROGRAMS FOR AUTISM DIAGNOSIS AND SERVICES, INCLUDING ABA SERVICES

The following Agencies/Programs will evaluate children for a diagnosis of Autism and provide services. Most of the agencies listed here use ABA (Applied Behavioral Analysis) therapy. They are not all local, but they service children in Hamden. The goal of ABA therapy is to increase positive behaviors and decrease those behaviors that are harmful or interfere with learning. ABA therapy can be done in the child's home or center. When a child receives services, most programs will work with you as educators and the families to understand more about the therapy. The diagnosis of Autism by these programs is medically based and can be used to bill insurance, however it is important that families talk to the individual agencies as well as their insurance provider to understand their family's particular situation.
